

## **EQUINE SEMEN WAIVER & RELEASE OF LIABILITY**

**Please read the following carefully and sign the appropriate areas.**

Any equine semen orders requiring shipment must be placed at least 7 business days before the estimated date of insemination or from when delivery is required. For all orders picked up at our clinic, a minimum of 48 hours' notice must be provided to process the order.

For all shipments emanating from Horizon Equine Veterinary Clinic, please allow ample travel time to avoid any unforeseen shipment delays. Refer to the Horizon Equine Shipping details for further information.

I \_\_\_\_\_, agree to hold Horizon Equine Veterinary Clinic Ltd blameless for any shipment delays or complications. I understand that once the shipment departs Horizon Equine Veterinary Clinic, they are no longer liable for the shipment or its contents. I understand that the parties that arranged shipment, if other than Horizon Equine Veterinary Clinic need to be contacted with any questions or concerns.

**Please read, initial, and sign the following.**

\_\_\_\_\_ For all equine semen orders Horizon Equine Veterinary Clinic requires a valid credit card on file and payment before orders are shipped or picked up. Including but not limited to receiving, dispensing, handling, tank charging, shipping charges, tank rentals, customs fees or any other fees associated with equine semen orders, I understand and accept that payment is required before orders can be processed.

\_\_\_\_\_ I acknowledge and understand that there are inherent risks of loss or damage when handling fresh and frozen equine semen and that even when all proper handling procedures are followed by our trained personnel there is a risk that semen can be damaged or lost when handling.

\_\_\_\_\_ No shipment departing in a tank rented from Horizon Equine Veterinary Clinic will be shipped in any dry shipper tank that does not meet Horizon Equine's quality assurance standards. I am aware that all shipper tanks are Dry Shippers that do not contain liquid nitrogen. All tanks rented from Horizon Equine are tested and rated for their lifespan. All tanks are guaranteed for 10 days.
